PURCHASE ORDER PROCESS

We only accept Purchase Orders from Municipal, County, and State Government and school districts.

1. Signing up for a course at <https://midatlanticpesticide.com> and selecting “purchase order” as your payment method will provide you with an invoice (registration acknowledgement) both on screen and via email.
2. Please provide the purchase order number when registering if it is known.
3. Please register using the proper name of the government institution, and provide the billing address, phone number, and contact number for the purchase order processing.
4. Our **Business Registration Certificate (BRC)**, and our **W9 form** required for your business office are attached to this document. The FEIN # is on the attached W9 and the BRC.
5. Once the PO is generated please mail us a copy to:

Dear Business Representative:

Congratulations! You are now registered with the New Jersey Division of Revenue.



General Instructions

Future developments. Information about developments affecting Form W-9 (such as legislation enacted when we release it) is at www.irs.gov/fw9.

Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following:

- Form 1099-INT (interest earned or paid)
- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)

- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
- Form 1099-C (canceled debt)
- Form 1099-A (acquisition or abandonment of secured property)

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.

If you do not return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See *What is backup withholding?* on page 2.

By signing the filled-out form, you:
